## **Annual Report of the Chairman 2024/25**

The Trustees have continued to meet six times a year at regular intervals at the Catenian Head Office, Prologis Park, Coventry. The majority of Trustees attend in person and there is a video link to allow attendance when travel difficulties or other circumstances arise. There is an Emergency Committee on call to act quickly if urgent requests for assistance are received and funds can be made available in as little as 48 hours.

The names of the nine current trustees are detailed in the Annual Report and Accounts and comprise eight members of the Catenian Association and a lady Coroner. The senior offices previously held by the eight members of the Association are: GBNP/CC Chairman, Grand Secretary, Grand/Association Treasurer, four Directors one of whom is a former Director for overseas development (Grand & Central Councils). There is a wide range of experience amongst the Trustees including, accountancy, insolvency, investments, legal, medical, pensions, social security benefits, taxation, and working for various charities. Many of the Trustees have served on Circle Benevolent Boards (CBB) and also dealt with a large number of applications for assistance whilst previously serving as Provincial Directors.

Loans to Beneficiaries are reviewed every two years and as many of these were made over ten years ago the knowledge and advice of Trustees holding office for many years proves invaluable. Confidentiality and sensitivity are the overriding principles of both the Trustees and the CBBs when dealing with applications for assistance from a Member or their dependents. Circles have an obligation by rule to have an effective Circle Benevolent Board of which the responsible Director is an ex-officio member. The Trustees would ask every CBB to be vigilant of members and their dependents where assistance may be required and the Charity's Website contains all the information necessary for potential applicants.

As can be seen from the table of statistics over the last three years the total value of monies dispersed by the Fund has increased by 57% since 2022/23 and Members are asked to continue and, in some cases start making regular donations to ensure the Fund can meet the needs of applicants assuming this trend will continue. The large majority of income has come from investments held but this will decrease as these are cashed in to meet demands on funds
